Candidates must produce all original documents / certificates at the time of written test / interview on demand for verification. Only shortlisted candidates will be called for written test / interview through personal discussion after verification of documents. The walk in written test / interview will be taken in English/Hindi.
- Qualification & experience required are as per guidelines; experience shall be counted after acquiring the essential qualification; age limit and experience will be considered as on date of Interview.
