**SPECIALTERMS AND CONDITIONS APPLICABLE TO FULL TIME CONTRACT DENTAL SURGEON:**

1. Dental Surgeon shall be recruited for a period of 1 year.
2. Private practice will not be allowed.
3. Available on call 24x7.
4. The Dental Surgeon shall be responsible for all cases undergoing treatment under his supervision in his discipline.
5. He/She will be entitled for the leave @ 2.5 days for each month of work on pro-rata basis in a calendar year. In the event, the specialist prefers not to avail the leave, the same may be encashed to a maximum limit of 30 days/year.
6. The number of vacancies may be changed without any prior notice.
7. No. TA/DA will be admissible either for the '**Walk- in- interview**' or for joining the post.
8. The Competent Authority reserves the right to fill up all post or not to fill up any post or cancel the interview process at any stage.
9. Selected candidates will have no claim for regularization of the service in the hospital.
10. Hostel accommodation/quarters/uniform will not be provided.
11. The selected candidates will have to join within time as given in the offer of appointment.
12. The selected candidate will have to furnish a DD/Bankers Cheque for an amount of Rs. **30,000/-** (Rupees Thirty Thousand Only) drawn in favour of '**ESIC Fund A/c No 1**' payable at Vapi, towards security deposit

14. Private practice is strictly not allowed. If found guilty, suitable action as provided under the relevant rules shall be taken.
15. In case regular candidate in, the appointment shall be terminated as per the condition of the contract.
16. No claim for any service benefit like, PF, Pension, Gratuity, medical Allowance, Seniority, Promotion and leave will be admissible.
17. Candidates must be registered with Gujarat Medical Council or MCI before joining the post.
18. The candidate who is in the Service should submit "No Objection Certificate" from the employer at the time of interview.

23. The candidates shall be governed by the relevant Rules and Regulations adopted by the ESIC in this regard.
24. Candidate seeking reservation benefits for SC/ST/OBC/EWS must ensure that they are entitled to such reservations per eligibility prescribed in the Notice.
